- 1 .Bachelor's degree in Law with honors from the College of Law - University of Baghdad in 1963.**
- 2 .Doctorate in Private Law with honors from the University of Paris in 1970, preceded by a Higher Diploma in Law from the College of Law - University of Aix-en-Provence.**
- 3 .Appointed as a lecturer at the College of Law and Politics - University of Baghdad on 1st September 1970, and promoted to Assistant Professor (Associate Professor) on 1st September 1974.**
